

VOLUNTEER RELEASE FORM

PLEASE READ CAREFULLY. THIS AGREEMENT INCLUDES A RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS AND DEPRIVES YOU OF THE RIGHT TO SUE THE SOUTH KING TOOL LIBRARY AND OTHER PARTIES. DO NOT SIGN THIS AGREEMENT UNLESS YOU HAVE READ IT CAREFULLY IN ITS ENTIRETY. SEEK THE ADVICE OF LEGAL COUNSEL IF YOU ARE UNSURE OF ITS EFFECT.

I, _______ (print name) hereby agree that if I am accepted as a volunteer worker for the South King Tool Library ("SKTL"), I will comply with all of the rules and regulations which may be established from time to time by SKTL. I understand that failure to comply with the rules and regulations of SKTL may result in my immediate termination as a volunteer. I also understand and agree that if accepted as a volunteer, all services performed by me will be performed on a strictly volunteer basis, and that I will receive no remuneration, pay or compensation of any kind.

I am fully aware that there are risks involved and hazards connected with handling tools and performing other volunteer tasks. I am volunteering with full knowledge that it may be hazardous to me and/or my property. I voluntarily accept all associated risks with volunteering and assume full responsibility for any risks of loss, property damage and/or personal injury, including, without limitation, serious bodily injury, permanent disability, paralysis and death that may be sustained by me or a third party, or any loss or damage to property owned by me or a third party, exposure to extreme conditions and circumstances, accidents, illness, dangers arising from the use of the tools, whether caused by the Released Parties' negligence or otherwise. I acknowledge that SKTL is under no duty to supervise or monitor my own actions or the actions of any other individual.

I hereby release, waive, discharge and covenant not to sue SKTL and Fiscal Sponsor, and all their respective officers, directors, agents, servants, or employees (the "*Released Parties*") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, any third party, or any of my property, whether caused by the negligence of the Released Parties or otherwise, while volunteering. I acknowledge that Fiscal Sponsor only provides certain financial services to SKTL and does not control SKTL or otherwise participate in its operations.

I understand that this waiver binds the members of my family and spouse (if any), and my heirs, assigns, next of kin, and personal representative (if applicable), for whom, through this instrument, I am releasing, waiving, discharging and covenanting not to sue the Released Parties. This waiver shall be construed in accordance with the laws of the State of Washington without regard to its principles of conflicts of laws.

I understand that public relations are an important part of volunteering with SKTL. On behalf of heirs, my personal representatives and myself, if accepted as a volunteer, I give the South King Tool Library permission to use and publish photographs taken of me as a volunteer for use in its public relations effort.

In signing this agreement, I acknowledge and represent that I have carefully read it, I understand its contents, and I am signing it voluntarily as my own free act and deed. I am not relying on any oral representations, statements, or inducements not included in this agreement. I am at least 18 years old and fully competent to execute this agreement. I execute this agreement fully intending to be bound by its terms.
